The Consumer hereby agrees to accept this service on his/her premises and to pay the bill by the due date. Late charges will be added on all accounts not paid by the due date. It is understood that service may be discontinued to the outdoor light and/or metered account(s) of the Consumer if the outdoor light account is unpaid. All accounts are subject to the Service Rules and Regulations of Hart Electric Membership Corporation.

This contract is for a **period of 5 years**, and will continue until terminated by either party on written 30-day notice, and the Provider and the Consumer both fully understand the agreement as set forth above. The Provider reserves the right to revise charges if deemed necessary by the Board of Directors.

It is further understood and agreed that the pole and all of the fixtures shall remain property of the Provider and may be remove on failure to pay the bill when it is due and on the termination of this agreement. It is further agreed that the Provider may enter upon the premises to remove said pole and fixtures as herein provided and for the further purposes of making repairs.
